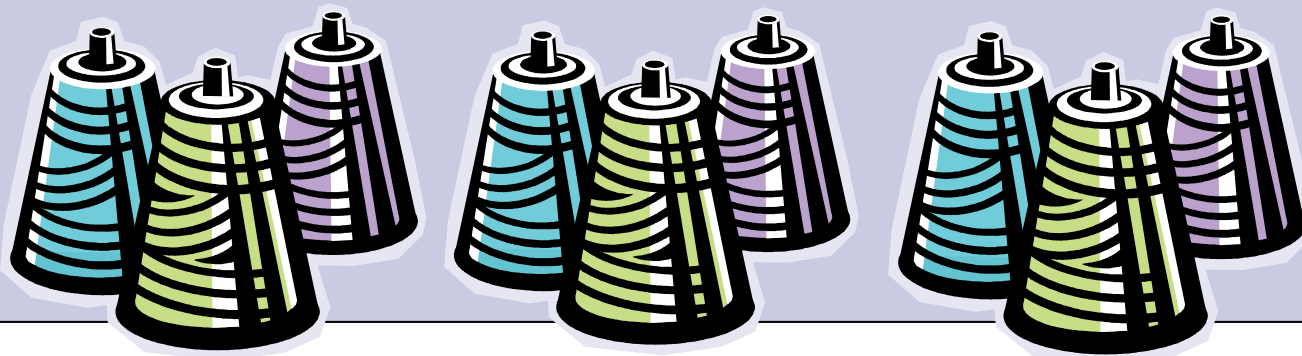

## April Program

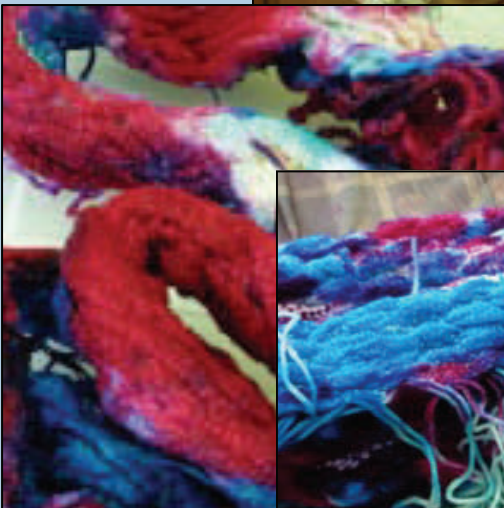
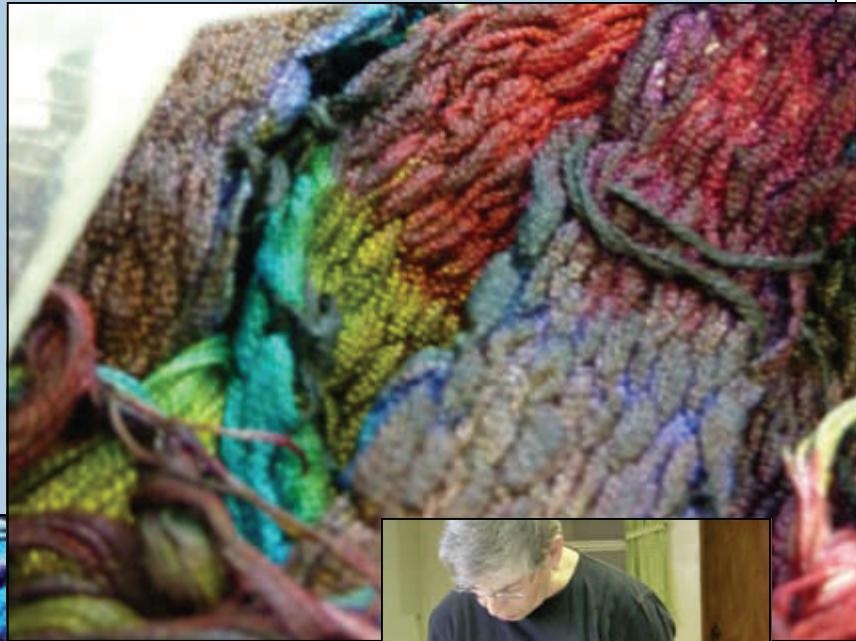
